SVDP OF SANTA CLARA COUNTY PROVIDES SAFETY NET SERVICES TO THE PRECARIOUSLY HOUSED AND HOMELESS COUNTYWIDE THROUGH OUR 24 CONFERENCES, FOOD PANTRIES, AND SISTER COUNCIL THRIFT STORES. THESE SERVICES WERE DELIVERED TO OVER 22,400 INDIVIDUALS THROUGH OUR VOLUNTEER NETWORK OF OVER 500 PEOPLE DELIVERING 32,000 HOURS OF SERVICE.
